## "Fur Trapper, Indian Agent, and Union Brevet Brigadier General"

At 16, Christopher Houston "Kit" Carson followed the Santa Fe Trail to NM, learned the skills of a trapper, became fluent in: Spanish, Navajo, Apache, Cheyenne, Arapaho, Paiute, Shoshone, and Ute.

At 25, at the mountain man rendezvous, he met an Arapaho girl. After winning a gun fight over her, they married and worked for Hudson's Bay Company with frontiersman Jim Bridger. Carson considered these "the happiest days of my life." His wife died after giving birth to their second daughter.

Later he met and married the daughter of a prominent Taos family: Josefa Jaramillo.

He led Br. Frémont on expeditions which "touched off a wave of wagon caravans." When Congress published Br. Frémont's reports in 1845, Br. Carson's reputation inspired writers to use him as the hero in dime novels.

In 1846, Br. Carson accompanied Br. Frémont to CA, there participated in several battles resulting in CA joining the Union

For heroic service he was promoted to Brevet Brigadier General during the Civil War. Afterwards, he was a military scout. Although objecting to tactics used against the Indians by Br. Colonel Chivington.

His fame was such that Br. "Buffalo Bill" Cody named his son after him.

In 1868, he was appointed superintendent of Indian Affairs in CO. He brought Ute Chiefs to DC., and arranged a treaty signed by Br. President Andrew Johnson. He fell ill while traveling in the east.

Br. Carson returned to Taos, sadly his wife Josefa died shortly after from complications giving birth to their eighth child. A month later, he died, at the age of 58, and is buried next to Josefa. His last words were: "Adios Compadres" (Spanish for "Goodbye friends").
