



# Oldest Masonic Document (in the Bri..sh Museum)

The Regius Poem, also known as the Halliwell Manuscript, is the earliest of the Old Charges of Freemasonry (Old Charges or Constitutions are documents outlining a "history" of freemasonry, tracing its origins to a biblical or classical roots). The age of the manuscript has been estimated to have been written about 1390, or earlier. It is described in a 1734 Catalogue of the Old Royal Library as "A Poem of Moral Duties".

It consists of 64 vellum pages of Middle English written in rhyming couplets. In this, it differs from the prose of all the later charges. The poem begins by describing how Euclid "counterfeited geometry" and called it masonry, for the employment of the children of the nobility in Ancient Egypt. It then recounts the spread of the art of geometry in "divers lands."

The document relates how the craft of masonry was brought to England during the reign of King Athelstan (924–939). It tells how all the masons of the land came to the King for direction as to their own good governance, and how Athelstan, together with the nobility and landed gentry, forged the fifteen articles and fifteen points for their rule. This is followed by fifteen articles for the master concerning both moral behavior (do not harbor thieves, do not take bribes, attend church regularly, etc.) and the operation

of work on a building site (do not make your masons labor at night, teach apprentices properly, do not take on jobs that you cannot do, etc.). There are then fifteen points for craftsmen which follow a similar pattern. Warnings of punishment for those breaking the ordinances are followed by provision for annual assemblies. There follows the legend of the Four Crowned Martyrs, a series of moral aphorisms, and finally a blessing.

"Fyftene artyculus bey ber sow ton, and fyftene poyntys ber bey wro ton." (Fifteen articles they there sought and fifteen points there they wrought.)

# **Regius Manuscript**

The origins of the Regius are obscure. The manuscript was recorded in various personal inventories as it changed hands until it came into possession of the Royal Library, which was donated to the British Museum in 1757 by King George II to form the nucleus of the present British Library. It came to the attention of Freemasonry much later, this oversight being mainly due to a librarian, who described it as "a Poem of Moral Duties" when catalogued in 1734. It was in the 1838–39 session of the Royal Society that James Halliwell, who was not a Freemason, delivered a paper on "The early History of Freemasonry in England", based on the Regius, which was published in 1840.

# Brief Excerpts of the Regius Poem:

The Regius poem sets out the basic tenets of Freemasonry. It contains fifteen articles and fifteen points, that are instructions on proper behavior, conduct and manners in various places, including the workplace, the church, and with employees. Much of the fifteen articles and points deal with proper workplace conduct.

The following is a summary of the main points:

# Summary of the Fifteen Articles

1. The master mason must be worthy of the confidence of the lords ; he must pay the fellows a fair wage with the lord's money

- 2. Every master mason must attend a general assembly, unless he can give a good excuse
- 3. The master mason shall not take on an apprentice for less than seven years and must lodge him during his apprenticeship
- 4. The master mason must not take any serfs as apprentice

5. The master mason shall take on neither bastards nor cripples (today's civil rights groups would have a field day with this one)

- 6. The apprentice shall be paid less than the fellows, but his salary shall increase as he progresses
- 7. The master mason shall employ neither thieves nor murderers a sensible precaution
- 8. The master mason may discharge an incompetent worker and replace him with another
- 9. The master mason must make sure that the foundation of the building is well-laid
- 10. The master mason must never take over, or meddle with, the work of another master mason, or be fined a penalty of ten pounds (that was a lot of money back then)
- 11. A mason shall not work at night, except to study
- 12. One shall not disparage the work of one's fellows
- 13. The master mason must give his apprentice a complete education
- 14. The master mason shall not take on an apprentice unless he has enough work for him
- 15. The master mason must not leave his fellows astray, because he must care about their souls

# Summary of the Fifteen Points

1. A man of the craft must love God and the holy church as well as his fellows

2. Masons must be paid for holidays

3. The apprentice must keep secret all that his master tells him and all that he hears or sees in chamber

4. The apprentice shall not be false to his craft, nor to his master or fellows, since the same law as theirs applies to him

5. Masons must receive their salary from their master humbly. The master must discharge a mason before noon if he has no more work for him

6. Quarrels between masons must be settled amicably, after the day's work is done or on a holiday

7. A mason shall not sleep with the wife of a master nor a fellow's wife or concubine

8. A master can allow a fellow to mediate between himself and other fellows

9. Fellows must take turns serving at table, buying the food and accounting for what they spent

10. A mason shall not support anyone who persists in wrongdoing; they shall be called before an assembly and excluded from the craft

11. A mason must teach another, whose work is imperfect, in a friendly manner

12. Masters, fellows, lords and local authorities shall agree in assembly to promulgate laws for the craft, and punish those who do not respect them

13. A mason shall swear never to steal, nor be accomplice to a thief

14. A mason must swear to be true to his master, his fellows and his king

15. He who disobeys the laws of the assembly shall be called before it to make amends. If he persists in his fault he shall be excluded from the craft and imprisoned, and his goods confiscated
